#### **Career Opportunities**

Nursing assistants may find employment in nursing homes, hospitals, and rehabilitation facilities caring for varying degrees of incapacitated individuals. Working under the direct supervision of Registered Nurses and Licensed Practical Nurses, CNAs will feed residents, make beds, and assist in activities of daily living including assisting in personal hygiene including shaving, bathing, nail care, dressing, and toileting. Nursing assistants are also responsible for positioning residents, transporting residents, obtaining vital signs, maintaining a clean environment, and reporting any health and safety issues observed to the nursing staff.



# **Program Requirements** (must be completed before students can register)

- At least 18 years of age and have a high school diploma or GED.
- Have a current Health Care Provider CPR card.
- Have documentation that all health exam and immunization requirements have been met.
- Complete the CORI and SORI forms to authorize a search of records for past criminal or sexual offenses. Depending on the contents of a student's CORI or SORI reports, participation in the program or a cooperative clinical related thereto may be denied.
- Pass a pre-registration exam (reading & math) at 100%.
- · Meet all technical standards.
- Complete the MassBay registration form.

Other suggested pre-requisites for success: have reliable transportation, be English language proficient (read/speak), and meet the essential functions of a Nurse Assistant (mature and professional demeanor, friendly helpful attitude, etc.).

#### **Description**

#### **CU 152 NURSE ASSISTANT**

Instructional topics will include the roles and responsibilities of the Nurse Assistant, understanding the elderly, safety, food service, personal care, elimination, restorative nursing, use of assistive devices, hygiene and infection control, and work ethics of a professional member of the nursing and health team.

Classroom instruction will be held on some Friday evenings (5:30 pm—9:30 pm) and weekends (8:00 am—4:30pm, Saturday/Sunday) in Framingham.

Clinicals will be held on Saturdays & Sundays from 8:00 am—4:30 pm at a long-term care facility.

Enrollment is limited to 15 students per class. This course exceeds the required 75 hours of classroom training. There are 32 hours of supervised on-the-job training in an approved long-term care facility as mandated by the Massachusetts Department of Public Health. Successful completion of the course enables students to take the Red Cross Nurse Aide Competency Evaluation (NACE) Test.
